However, Nepa Limited shall allow vari ation to the extent of 0.5% in weight to take care of variation in weigh bridges at the loading point and unloading point. For any shortage beyond 0.5%, the cost of material shall be recovered from t he supplier on F.O.R. Nepanagar basis.
