6. WEIGHMENT:

The material on receipt at our end shall be weighted. The weight recorded at our end and that of Challan weight, whichever is less will be taken in to account. However, Nepa Limited shall allow variation to the extent of 0.5% in weight to take care of variation in weigh bridges at the loading point and unloading point. For any shortage beyond 0.5%, the cost of material shall be recovered from the supplier on F.O.R. Nepanagar basis.

7. PENALTY: In case of non execution of full order by a party within the stipulated period mentioned therein the purchase order, penalty 5% of the order value on unexecuted quantity shall be recovered for 1st month after expiry of delivery period and if still order remain unexecuted once again during subsequent month, additional 5% penalty shall be imposed on balance quantity as risk and cost of the supplier. Afterwards, order shall stand automatically cancelled. In such cases besides the recovery of penalty full amount of PBG shall be forfeited.
